Technical information about this website's accessibility

Westmill Parish Council is committed to making its website accessible, in accordance with the Public Sector Bodies (Websites and Mobile Applications) (No. 2) Accessibility Regulations 2018.

Compliance status

This website is not compliant with the <u>Web Content Accessibility Guidelines version 2.1</u> AA standard. Non-compliance with the accessibility regulations falls under the <u>Disproportionate burden</u> heading of the regulations. The non-compliances and exemptions are listed below:

Non-accessible content

The content listed below is non-accessible for the following reasons:

Some images do not have a text alternative, so people using a screen reader cannot access the information. This fails WCAG 2.1 success criterion 1.1.1 (non-text content).

Navigation and accessing information

There's no way to skip the repeated content in the page header (for example, a 'skip to main content' option).

It's not always possible to change the device orientation from horizontal to vertical without making it more difficult to view the content.

It's not possible for users to change text size without some of the content overlapping.

Content that's not within the scope of the accessibility regulations

The accessibility regulations <u>do not require us to fix PDFs or other documents published before 23 September 2018</u> if they're not essential to providing our services. Any new PDFs or Word documents we publish will meet accessibility standards.

We do not plan to add captions to live video streams because live video is <u>exempt from meeting</u> the <u>accessibility regulations</u>.

Improving website accessibility

We've assessed the cost of fixing the issues with navigation and accessing information. We believe that doing so now would be a <u>disproportionate burden</u> within the meaning of the accessibility regulations. We will make another assessment when this document is reviewed which is likely to be in May 2024.

Preparation of this accessibility statement

This statement was prepared on 26/04/2021. It was last reviewed on 21/04/2023. This website was last tested on 21/04/2023. The test was carried out by Westmill Parish Council using WAVE by WebAIM https://wave.webaim.org/extension/.
